I serve as 1 of 8 members on the Dean's Head of Operations (HOPs) Leadership Team and support college operations, including annual budgeting and allocations (total annual operating budget/allocation is \$66.8 million, not including tuition, research funding and clinical revenue). As a major academic unit (MAU) Chair/Director on this team, I worked closely with the Dean and Chief Financial Officer to develop a new funding model for FY20 for the college which includes 26 MAUs, including 2 basic science departments, 20 clinical departments, and 4 social/behavioral science and research departments/units. I also provide strategic leadership and accountability to shape and implement college and university-wide public health initiatives in research, education, community outreach and engagement, and service. In the past year, I also developed guidance for a new school of public health at MSU and led the Provost's Public Health Steering Committee.

Director, Division of Public Health

June 2017 – present

I am the administrative and programmatic leader of the Division of Public Health, established in January, 2015 as a community-engaged public health program at the MSU-CHM Flint campus. I left Hopkins in 2016 to join this Division as an Endowed Professor in the midst of the Flint Water Crisis, and less than a year later I began assuming administrative responsibilities for the Division. When I started in 2016, there were 15 staff and 4 faculty. The Division currently has 31 faculty, 120+ staff, \$71 million in external grant funding, and a \$7.6 million operating budget. I served as the Interim Director from June 1, 2017 - May 31,

2019 and was installed as the permanent Director June 1, 2019. In addition to full fiscal responsibility for the Division, I am responsible for faculty, staff, and student success and evaluation.

I provide programmatic leadership for public health and clinical integration initiatives. I serve on the Executive Committee and work directly with the Department Chair on strategic planning, implementation, and evaluation of departmental, hospital- and community-based public health initiatives.
